7.1	Are the students who attend the academy site receiving different teaching?		
7.1.1	(SKn) No – The students at school and at home receive the same online provision. We do have some SCITT Trainees (Trainee Teachers) who are working with small groups of		
	students on site who require extra help.		
7.2	How are you monitoring the Quality Assurance of Lessons?		
7.2.1	(AP) We have protocols in place for how the work is set on SMHW (Show My Homework) so that it is easy for the students to follow.		
7.2.2	(AP) SLT have been in every 1 <sup>st</sup> Live lessons, and attended some 2 <sup>nd</sup> & 3 <sup>rd</sup> Live lessons.  We've watched the pre-recorded lessons and provided feedback. Heads of Department have also watched the lessons and given feedback. We have used the way Josh Hocking has feedback to the Maths Department as a benchmark for the rest of the staff.		
7.2.3	(SH) We monitor the QA daily and liaise with families and students.		
7.2.4	(SKn) I recently presented a Maths Live lesson and a colleague gave me feedback both technical and teaching, it is happening and happening very well.		
7.3	How do you monitor the students keeping up with the lessons?		
7.3.1	(SKn) There are some issues with some students trying to produce perfect work and spending too long on a subject. We have tried to be strict with advising how long they should spend on a task.

7.5.1	(SKn) Yr11 1-2 lessons per day Yr9 & 10 1 lesson per day		
7.5.2	(HM) We are continuing to support and providing paper copies of all lessons where required.		
7.5.3	(LD) The Smart Start assemblies are working very well		
7.5.4	(HM) The SEND families have been very positive about the assemblies also.

7 7	(SKn) There are some outliers in Yr11 with students who just don't attend school. Yr9		
7.7	have a high level of additional needs.		
7.7.1	(SKn) Many students are working out of sync to the timetable due to unique home lives.		
7.7.2	(SKn) We are unable to track attendance, although we can check engagement levels and work submitted, but we do have some students working late in the night because that it when they are able to access devices.		
7.7.3	(SKn) We have increased the amount of live lessons this week for our students in Yr7 & 8		
7.7.4	(SH) We sent out over 2000+ WOW cards in January 2021.

7.7	Yr10 are currently taking assessments, and our focus remains on Yr11 to ensure we have a full file of work to enable assessments of grades.	
7.8	(SKn) We will need to help students reintegrate as they return to school. We learned	
7.0	lessons from September and are looking forward to students returning.	
7.9	Yr10 will miss out on Work Experience, what can we do about this?	
7.9.1	(SKn) We have just had a presentation on virtual work experience that will be	
	presented to Yr10.	
7.9.2	(SKn) We are slso working with Yr9 on their options and providing guidance to them for	
	a full rounded KS3 option. Students are regularly signposted to work focused	
	information.	
7.9.3	(ZJ) Sam is working very well to provide tools and information to our students for	
7.10	employability.  Do you think that as students return they will need an individual plan?	
7.10.1	(SKn) Arguably the students require this during a regular school time. Focusing on	
7.10.1	student's needs, Mental Health referrals more than doubled during lockdown, but	
	some students have thrived.	
7.11	(RR) I have several Pupil Premium queries that I will confirm with RG at our link catch	
	up.	
7.12	Could you explain the Assessment Guidance for the exam years?	
7.12.1	(SKn) We believe that priority to exam groups will be given to return to school when	
	able. We continue to have online bespoke arrangements after half term. We are unable	
	to award grades on any work or assessments until the final grading to stop any grading	
	assumptions from students and families.	
7.13	It is listed in the report that several staff were receiving support prior to lockdown, is this still happening?	
7.13.1	(SKn) We are unable to continue any formal process due to the pandemic (staff also	
7.13.1	have home/work pressures). SOC and AP are working with those colleagues. Staff have	
	been provided buddies, and are working in teams. Staff are being supported remotely,	
	but not on formal capability reviews. We have seen a marked improvement in 1 staff	
	member, further improvement from 2 staff members – the time away has had a	
	positive impact on the staff.

	first lockdown. Yesterday we had 118 student on the HWA site.	
10.1.2	(SKn) We are still keeping student in year group bubble, this means more staff are required on site, and extra rooms are required which means further cleaning.	
10 1 2	(SKn) We have increased our online provision including more live lessons. We provide	
10.1.3	an introduction to the lessons, and an exit test to assess learning within the lessons. We	
	have blended learning of live and re-recorded lessons and have seen good engagement	
	and high standards of work submitted.

	and chastising where necessary to ensure our students are attending lessons. Our have done an outstanding job during this 3 <sup>rd</sup> lockdown.
